



Giftany Promotion Terms & Conditions

This Giftany Promotion (“Promo”) is conducted by SingTel Mobile Singapore Pte. Ltd (“**Singapore Telecommunications**”, “**Singtel**”).

By registering or taking part in this Promo, all persons participating herein (the “Participant(s)”) agree to be bound by these Promo Terms and Conditions.

Giftany Promotion (“Promo”)

1. The Promo is open to all individual Singapore citizens and residents of the Republic of Singapore who may purchase or has purchased a digital gift card from Giftany online store. By participating in the Promo, you represent and warrant that you have met the eligibility criteria set out under these Promo Terms and Conditions.
