

Lucky Draw Terms and Conditions

1. This lucky draw is organised by Singtel Mobile Singapore Pte Ltd. (“Singtel”). Employees and agents of Singtel engaged in connection with the development or operation of the lucky draw are not eligible to enter the lucky draw. Persons below the age of 18 are required to obtain their parents’ consent before participating in the lucky draw, and confirm to the organizing team that such consent has been given, by their participation in the lucky draw. The organizing team reserves the right to not allow participation by any person, at its discretion. Each participant is solely responsible for ensuring that participating in this lucky draw is not illegal or prohibited by the laws or regulations of any country relevant or applicable to the participant. The organizing team reserves the right to disqualify an otherwise eligible person from winning a prize and/or substitute another person as the winner in the event that the organizing team in its absolute discretion believes that the particular person may have contravened, will contravene or has contravened any of these Terms and/or may bring the organizing team into disrepute. 6. Singtel accepts no responsibility for entries not successfully completed due to a technical fault technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
