

## Terms & Conditions for Singtel ReadyRoam 1 Million KrisFlyer Miles Promotion

- The Singtel ReadyRoam 1 Million KrisFlyer Miles Promotion ("Promotion") will be available from 23 April 2024 to 30 June 2024, both dates inclusive ("Eligible Period"). The Promotion is open to Singtel Mobile Postpaid customers (both residential customers and customers on the Corporate Individual Scheme) who are eligible to purchase Singtel's roaming services.
- 2. To qualify for the Promotion, participants need to purchase the ReadyRoam Asia, ReadyRoam Worldwide or ReadyRoam Others plan ("Eligible ReadyRoam Plan") via the My Singtel app and complete the travels for which they purchased the Eligible ReadyRoam Plan within the Eligible Period.
- 3. Ten (10) winners will be chosen at random to win 100,000 KrisFlyer miles ("**Prize**"). Winners must be an active Singtel Mobile subscriber [as at the date they are notified that they are a winner (if applicable)] in order to qualify for the prize. Each purchaser of an Eligible ReadyRoam Plan shall have one (1) chance in the lucky draw, except for purchasers of an Eligible ReadyRoam Plan who are also subscribers to the M, L, Pro or Family Phone Plan, who shall have two (2) chances in the lucky draw.

Winners will be notified via a telephone call and SMS within five (5) working days after the draw date and will have to provide their KrisFlyer account details to Singtel for the purpose of crediting the KrisFlyer miles. The KrisFlyer miles will be credited into the winners' Krisflyer accounts by 31 July 2024. Singtel will diligently attempt to contact all 10 winners. However, if a winner cannot be reached within five (5) working days, the prize will be forfeited and subsequently awarded to an alternate winner.
